- ! We use tracking cookies valid for **30 days**. Any user who clicks your unique link and completes a subscription purchase within 30 days will be credited to your account.
- ! Tracking is dependent on the proper functioning of cookies and user behavior. We are not responsible for technical issues that prevent tracking.

4. Payouts

- ! Payments are made on a **monthly** basis via **[Payment Method]**.
- ! The minimum payout threshold is **\$50**.
- ! Payments will be processed **[14] days after the end of each month**, allowing for refunds and chargebacks.

5. Affiliate Obligations

You agree to:

- ! Promote [Your App Name] truthfully and ethically.
- ! Disclose your affiliate relationship per **FTC guidelines**.
